1. Project Overview

Nebrexan Inc. seeks proposals from licensed and insured contractors to perform electrical, plumbing, and carpentry work at its new food production and retail space located at 208 S Hampton Rd, Suite 100, DeSoto, TX. The goal of this build-out is to prepare the suite for operation as a small-batch popcorn and ice cream retail site, including installation of a 3-compartment sink, plumbing improvements, electrical panel upgrade, and door additions.

2. Project Scope

Contractors may submit proposals for one or multiple trades. Please indicate your scope below:
□ Plumbing Only
□ Electrical Only
□ Carpentry / General Construction Only
□ Full Project (All Trades)

A. Plumbing

- Install 3-compartment sink with drainboard and faucet set.
- Install mop sink or floor drain (confirm with city inspector).
- Provide hot/cold water supply and tie-ins to main drain line.
- Verify or install grease interceptor and venting as required.
- Confirm hot water heater sizing.
- Provide final testing, inspection, and permit closeout.

B. Electrical

- Inspect and upgrade electrical service panel to 200A single-phase.
- Add GFCI outlets near all sinks.
- Provide new dedicated outlets for popcorn equipment, warmers, coolers, and POS.
- Label all circuits and provide updated panel schedule.
- Ensure compliance with City of DeSoto electrical codes.

C. Carpentry / General Construction

- Install new French door (owner may provide material).
- Install one additional door (location TBD).

- Frame, patch drywall, and paint as needed.
- Ensure all work meets commercial safety and ADA standards.
